

**Public Hearing Notice and
Proposed Project Selection for the 2026 CDBG Program
Indiana County “on behalf of” Center Township**

A public hearing will be conducted on Thursday, June 18, 2026 at 1:00 PM at the Center Township Municipal Building located at 1212 Neal Road, Homer City, PA by Indiana County “on behalf of” Center Township. The purpose of the meeting is to discuss Center Township’s proposed 2026 CDBG Entitlement program and Center Township’s plans to utilize the funding and submission of a 2026 CDBG application.

The public hearing is accessible to individuals with disabilities and/or for persons with Limited English Proficiency. The purpose of the public hearing is to discuss the Community Development Block Grant (CDBG) project selection and the 3-Yr Plan for Indiana County “on behalf of” Center Township. The hearing will discuss the selection of activities and why any proposed activities were not selected for funding. The selected 2026 CDBG activity is to fund the construction of storm sewer drainage with the re-construction of the roads. Center Township anticipates undertaking the activity in Luciusboro, PA.

The County of Indiana “on behalf of” Center Township will receive an allocation of approximately \$97,720.00 of 2026 CDBG funds from the Commonwealth of Pennsylvania. In addition, the County of Indiana “on behalf of” Center Township anticipates the receipt of no program income during the 2026 program year. At least 70% of the available funding must be used for activities which benefit low-moderate income persons. The proposed activities must benefit at least 51% low-moderate income persons in the service area to qualify as a low-moderate income project. The PA Department of Community and Economic Development (DCED) has announced the application submission deadline of October 30, 2026 by 5:00 PM.

If the County of Indiana “on behalf of” Center Township would undertake activities that result in the displacement of families or individuals, then the County of Indiana’s policy for minimizing such displacement would be in effect. The County of Indiana “on behalf of” Center Township is responsible for replacing all low-moderate income housing units that may be demolished or converted as a result of the use of CDBG funds.

All interested citizens are encouraged to attend and will be offered the opportunity to give oral testimony at the public hearing and/or to present written comments concerning the proposed CDBG activities and 3-Yr Plan, the selection process and any other questions related to the CDBG program.
