

**Public Hearing Notice and
Request for Proposals for the 2019 CDBG Program
And 2016 CDBG Modification
Indiana County “on behalf of” Indiana Borough**

Notice is hereby given by Indiana County “on behalf of” Indiana Borough that it will conduct a public hearing on Tuesday, July 16, 2019 at 6:30 PM in the Indiana Borough Municipal Building located at 80 N 8th Street, Indiana, Pennsylvania. This meeting is accessible to individuals with disabilities and/or for persons with Limited English Proficiency. The purpose of the public hearing is to discuss the Community Development Block Grant (CDBG) program in general, the needs of Indiana Borough, and the Indiana County “on behalf of” Indiana Borough’s performance under the previously funded CDBG Program years, and to discuss the required Three-Year Community Development Plan of Indiana Borough for the 2019 CDBG application cycle. The public hearing will include the proposed modification to Indiana Borough’s 2016 CDBG contract to add the S. 7th Street Storm Sewer Replacement and Improvements Project due to unexpended funds from a completed activity.

The County of Indiana “on behalf of” Indiana Borough is expected to receive an allocation of \$190,683.00 of 2019 CDBG funds from the Commonwealth of Pennsylvania. In addition, the County of Indiana “on behalf of” Indiana Borough anticipates the receipt of no program income during the 2019 program year. At least 70% of the available funding must be used for activities which benefit low and moderate income persons. The proposed activities must benefit at least 51% low-moderate income persons in the service area to qualify as a low-moderate income project. The PA Department of Community and Economic Development (DCED) has announced the application submission deadline of November 1, 2019.

The following types of activities may be eligible for funding under the CDBG Program: water and sewer line replacement and improvements; housing rehabilitation; construction of affordable housing; construction/reconstruction of public/community facilities; recreational facilities; public services that are new or provide quantifiable increase in the delivery of services; street improvements; historic preservation; removal of architectural barriers; code enforcement; economic development; acquisition and relocation; clearance and demolition; and general administration, planning, audit and preparation of the CDBG application.

If the County of Indiana “on behalf of” Indiana Borough would undertake activities that result in the displacement of families or individuals, then the County of Indiana’s policy for minimizing such displacement would be in effect. The County of Indiana “on behalf of” Indiana Borough is responsible for replacing all low and moderate income housing units that may be demolished or converted as a result of the use of CDBG funds.

All interested citizen are encouraged to attend and will be offered the opportunity to give oral testimony at the public hearing and/or to present written comments concerning the needs of Indiana County “on behalf of” Indiana Borough’s proposed CDBG Program activities, the prior use of CDBG funds as well as the CDBG Program in general.
