Why have a SALDO?

Indiana County ensures new construction sites and subdivisions are safe and functional through its Subdivision and Land Development Ordinance.

This ordinance requires builders to follow design standards, get approval for sewage systems, and have proper access to public streets.


Where does this ordinance apply?


It applies to all townships and boroughs in Indiana County except for:

- White Township
- East Wheatfield Township
- Indiana Borough •
- Blairsville Borough
- Burrell Township

Fee Schedule

Classes I—III Minor Subdivisions

(3 lots or less, no public improvements) \$75.00 per class

Class IV Major Subdivision

\$150.00 PLUS \$10.00 / each new lot (4 or more separate deeded parcels or lots w/ public improvements)

SUBDIVISION CLASSES I—IV WHERE DOISTART? Contact a Land Surveyor and have your Surveyor proposed plan drawn. Consult an Attorney. You'll need a new deed to be recorded with your new **Attorney** plan. Complete an application. Go to ICOPD.org, stop by the office (801 Water Street) or call us at (724) 465-3870 ICOPD.org and we'll mail one to you. Now would be a good time to schedule a free Preliminary Meeting. We can help with your application and answer your questions. Sewage Existing sewage systems must be **Enforcement** inspected. New sewage systems need a permit. Contact Sewage Enforcement for more details at (724) 548-7743. Your plan and Non-Building Waiver (if applicable) will need to be signed by Municipality your Municipality. Bring your signed plan, application and sewage paperwork to the Planning Planning Office to be reviewed by the Planning Office Commission at their next monthly meeting. Take your approved plan and new deed Register & ₹to the Register & Recorders Office to Recorders be recorded. Call Office (724) 465-3860 for the current fee schedule.

The Indiana County Planning Commission conducts monthly public meetings to consider new proposals. These proposals are either approved, not approved, or tabled for further discussion. The Commission also addresses ongoing projects during these meetings. All are welcome to attend.

90-DAY TIME LIMIT

Upon approval of your proposal, you will have 90 days to record the approved plan with the Register & Recorders Office. Plans not recorded within this timeframe will require reapproval from the Planning Commission for a fee of \$50.00
